Extracurricular Activities and Programs – 370

Interscholastic Athletics (375)

Athletes must display high standards of behavior, exemplify good sportsmanship, show respect for others, and abide by all eligibility and training requirements established by the Board of Education. Qualified personnel shall be provided for coaching and the supervision of individual sports. It is also recognized that a well organized and well conducted interscholastic athletic program is a potent factor in the morale of the high school student body and an important phase of good school/community relations. Too great an emphasis on winning contests or too consistent a record of losing contests are both harmful to the development of good attitudes among students and the public.

The following is a list of activities sponsored by Brookwood High School: Football, Girls Volleyball, Boys and Girls Cross Country, Wrestling, Boys and Girls Basketball, Boys and Girls Track, Softball, Baseball and Cheerleading.

The following is a list of activities sponsored by Brookwood Jr. High School: Football, Girls Volleyball, Boys and Girls Cross Country, Boys and Girls Basketball, Wrestling, Boys and Girls Track.

The Norwalk-Ontario-Wilton School District shall not discriminate in the opportunities provided for participation in athletic programs or activities, enforcing standards and rules of behavior, taking disciplinary actions or permitting facilities usage. Discrimination complaints shall be processed in accordance with established procedures.

Policy Conditions

- Participation in interscholastic athletics is limited to students in Grades 9-12 with participation of properly supervised teams from Grades 6, 7 and 8 also being permitted in a limited program within their own grade levels with other schools.
- The interscholastic athletic program is an integral part of the high school curriculum and comes under the authority of the principal to the same degree as do all other phases of the curriculum.
- Those coaches having direct responsibility for the conduct of the athletic program of the school are required to conform in all ways to the general education program as laid down by the Board of Education and the administration, including such matters as schedules, financial expenditures, relationships with other schools, and health and safety regulations.
- Brookwood High School is a member of the Wisconsin Interscholastic Athletic Association (WIAA), and in all athletic matters will adhere to the rules and regulations of that body and to the philosophy of sports which the WIAA encourages. The eligibility of students to participate in an athletic program is

determined in accordance with WIAA regulations and the Brookwood Athletic Handbook as approved by the Norwalk-Ontario-Wilton Board of Education.
