





1. To log on, go to this address <http://www.msdsonline.com/>  
User: NOW Password: falcons


2. You will enter your district's username and password.




3. Also, check the “remember username” box so you don’t have to retype this every time you log in. Additionally, add this page to your favorites list.
4. The first time you log in, the program will ask you to choose a default language. Pick your language of choice. In this system you only have the option of viewing your school district’s ebinders. Whether you choose your school district or all locations you will be have access to your school district information.



- Once you have made your selections, check the box that says “Don’t show this window again,” then click save. You will not have to do this step again if you continue to use the same computer to access the system.



- Once you’ve logged in, the screen should look like this.



7. Type the name of the product you would like to search for in the Search field. Click the Search button.
