VEHICLES REGISTRATION INFORMATION:

Students may drive to school on a regular basis - subject to the following conditions:

1. Completion of **THIS FORM** filled out and signed by parent/guardian and registered in the office.
2. Students must pay a \$5.00, registration fee and possession of a valid driver's licenses which will be copied and attached to this document and will then be issued a Brookwood parking pass. ***Keep this information up-to-date! (Failure to register your vehicle may result in the loss of driving privileges).***
3. Each car a students drives must be registered in the office. If students change cars in the middle of the school year, they will need to complete another registration card.
4. Parking only in the student parking area as designated by the administration.
5. Vehicles will not be used as a place to sit, loiter, or drive during the noon hour.
6. Cars and bikes must remain parked in the assigned area during the entire school day unless the student has been given expressed permission to use his/her vehicle or bike. Violation of this will result in suspension of driving privileges.
7. **Driving on the gravel by the fuel pumps / district house is strictly prohibited.**
8. **Damage to school district lawn(s) will result in the person paying for all damages and may result in suspension from school. Legal authorities may also be contacted.**
9. Following dismissal of school, cars are to wait until buses have exited.
